Introduction

Transition Technologies-Software Sp. z o.o. (NIP: 5272903279, REGON: 384186978, KRS: 0000800662, company registered in Poland, ul. Pawia 55, 01-030 Warsaw) respects the right to privacy of users of the website www.ttsw.com.pl). This document describes the rules for obtaining and using data obtained from users through the website and company profiles in Social Media. It also informs about the rights of users and methods of their execution.

What are cookies?

Cookies are small pieces of information, sent by the visited website and saved on the end device (computer, laptop, smartphone, etc.) that users use when browsing websites. They usually contain the name of the website from which it comes, the "life expectancy" of the cookie (ie, its lifetime), and a randomly generated unique number used to identify the browser from which the website is connected.

Cookies policy

In connection with sharing the content of the Transition Technologies-Software website, so-called Cookies, i.e. information saved by servers on the user's end device, which servers can read each time they connect to this end device, may also use other technologies with functions similar or identical to Cookies. In this document, information on Cookies also apply to other similar technologies used on our websites. Cookies are IT data, in particular text files, which are stored on the end device of the user of the Transition Technologies-Software website.

The purposes of using cookies:

- Adjusting the content of the website pages to the user's preferences
- Improvements in searching and browsing website content
- Optimization of website use (in particular recognition of the website user's device and appropriate display of the website),
- Creating statistics that help to understand how website users use websites, which allows improving their structure and content
- Maintaining the website user's session (after logging in), thanks to which the user does not have to re-enter the login and password on each subpage of the website,
- Providing users with advertising content more tailored to their interests.

Types of cookies:

There are two basic types of Cookies: current session and persistent. Current session cookies are files temporarily stored on the user's device until they leave the website or close the browser. Persistent files remain on the user's device for a specified period or until deleted by the user. As part of the Transition Technologies-Software website, we can use the following types of Cookies:

- "necessary" Cookies - enabling smooth use of services available as part of the website, e.g. authentication Cookies used for services that require authentication as part of the website; Cookies used to ensure security, e.g. used to detect fraud in the field of authentication on the website; Cookies, enabling the collection of information on the use of website pages,
- "functional" Cookies, enabling the user to remember user-selected settings and personalizing the user interface, e.g. in terms of the language or region of the user's origin, font size, website appearance, etc.,
- "positioning" Cookies, enabling users to provide advertising content more tailored to their interests.

Blocking or disabling Cookies:

In many cases, the software used for browsing websites (web browser) by default allows cookies to be stored on the user's end device. Website users can change Cookie settings at any time. These settings can be changed in particular in such a way as to block the automatic handling of cookies in the web browser's settings or to inform about them every time they are placed in the user's device of the website. Detailed information about the possibilities and ways of handling Cookies are available in the software (web browser) settings. Failure to change the cookie settings means that they will be placed on the user's end device, and thus we will store information on the user's end device and gain access to this information.

Disabling the use of cookies may cause difficulties in the use of some services as part of our website, in particular those requiring login. Disabling the option of accepting cookies does not, however, result in the inability to read or view content posted on the Transition Technologies-Software website.

Cookies can be placed on the end device of the Transition Technologies-Software website user, and then used by advertisers, research companies and multimedia application providers cooperating with the website.

Data collection and use

In accordance with the practice adopted in most websites, we store HTTP queries directed to our server. This means that we know the public IP addresses from which users browse the information content of our website. The viewed resources are identified by URL addresses. Our servers also automatically save data such as: page

request sent by the user, date and time of the request, device data (e.g. hardware model), browser type, browser language, operating system type.

These data are used to ensure the stability and security of websites' work. The collected logs are stored for an indefinite period as evidence used to administer the website and, possibly, for the purposes of explanatory actions conducted by state institutions authorized to do so pursuant to legal provisions.
